(3) This is if a school district imposes an income tax above the property tax amount. Based on \$50K with one personal, one spouse, and one dependent exemption.

(4) 2016 Rates per the City of Oakwood Water/Sewer survey. Based on the residential usage of 1,000 cubic feet/month.

(5) Income and school district averages are based on the number of the cities/villages with taxes.

Taxes are based on the 2015 property tax rate paid in 2016.
