 (4) 2015 Rates per the City of Oakwood Water/Sewer survey. Based on the residential usage of 1,000 cubic feet/month.  
 (5) Income and school district averages are based on the number of the cities/villages with taxes.

Taxes are based on the 2014 property tax rate paid in 2015.
