2016 FOURTH OF JULY VENDOR APPLICATION

The 2016 4th of July event in Rotary Park is seeking vendors for food and other appropriate 4th of July and Beavercreek items for this year. Vendors may be either from a commercial venture or a non-profit organization. Non-profit organizations that are accepted as a vendor will not be charged for a location in the park. For commercial vendors there will be a nominal \$25 fee payable in full before Friday, May 27.

Because there are no electric, running water, sewage or trash facilities available each vendor must be self-contained. If you have an electrical source that does not create noise (gas generators may not exceed 3700 watts) that would interfere with the events going on at the band stand, then please let the committee know what that source is.

All applications must be returned to the Department of Parks and Recreation, either in person or by mail, no later than May 27, 2016. You will be notified if you are selected as a vendor on or before June 17, 2016. You will be provided with a map showing the location you have been assigned and a parking pass - you will not be able to park multiple cars by your spot.

Space is limited and so the number of vendors that can be accommodated is limited. It is the committee's desire to have a variety of items and foods available. We will be looking to prevent item/food overlap between vendors. A suggestion: if you have something that is a signature item or food that no one else would have, try planning on that as your primary offering.

Be aware that non-profit organizations will have priority in selection when they and a commercial vendor are offering the same items/foods.

Vendors of non-food items that do not require the use of a booth please indicate that fact under "Additional Information".
