- (4) 2020 Rates per the City of Oakwood Water/Sewer survey. Based on the residential usage of 1,000 cubic feet/month.
- (5) Income and school district averages are based on the number of the cities/villages with taxes.

Taxes are based on the 2019 property tax rate paid in 2020.
